NOTIFICATION.

No. 16108 For.—15th December 1953.—Whereas a notice under proviso (a) to section 7 of the East Bengal Private Forest Act 1949, were issued by the Regional Forest Officer, Dacca Forest Division to the owner of Private Forests in the District of Dacca, as detailed in the schedule below and whereas the Appellate Committee appointed under this department notification No. 4458 For., dated 1st May 1951, after due consideration of the causes shown and evidence produced by the owner of these private forests unanimously recommends that management of these forests be vested in the Regional Forest Officer, Dacca, for a period of fifty years for their proper conservation and scientific management, the Governor in exercise of the power conferred by section 7 of the said Act, is pleased to direct that the control and management of the Private Forests detailed in the schedule below shall be vested in the Regional Forest Officer, Dacca Forest Division, for fifty years commencing from the date of taking over the forests.
