NOTIFICATION.

Whereas the Governor is satisfied that it is necessary to protect, improve and scientifically manage the private forests as detailed in the schedule below and that the Conservation of these forests should not be left to the owners thereof;

The Governor, in exercise of the power conferred by section 7 of the East Bengal Private Forests Act, 1949, is pleased to direct that the control of the aforesaid forests shall be deemed to have vested in the Regional Forest officer, Dacca Forest Division, for a period of fifty years, with effect from the last May, 1952.
